In partial modification of the letter cited in ref.7, as your institution did not satisfy one of the requirements of University (pass percentage) as stipulated by the University guidelines as approved by the syndicate, University has declined to confirm the autonomous status accorded by the UGC.

In the light of the directives accorded by the Honorable High Court of Madras and Apex Court of India, the following orders are issued.

It is hereby communicated that the Award of **Fresh Autonomous Status** is granted to your Institution under the UGC Scheme for Autonomous Colleges for a period of ten years with effect from **2019 - 2020 to 2028 - 2029**.

You are requested to constitute (wherever necessary) the Governing Body, Academic Council, Board of Studies, Finance Committee, Board of Examiners & other related statutory bodies and get the approval for New Regulations, Curriculum and Syllabi.

As per the guidelines of University Grants Commission (UGC), New Delhi, a onetime fee has been fixed by Anna University, Chennai, for the conferment of Fresh / Extension of Autonomous status.

In this connection, you are requested to send a Demand Draft for a sum of Rs.1,50,000/- (Rupees one lakh fifty thousand only) drawn in favour of "The Director, Centre for Academic Courses, Anna University, Chennai" to this office immediately, as approved in the Executive Committee Meeting of Centre for Academic Courses, Anna University.

The receipt of this communication may be acknowledged and the action taken is reported.
